



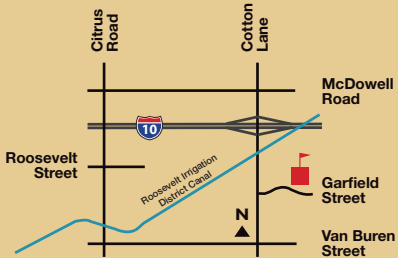

# Interstate 10 (Papago Freeway) Perryville Road Traffic Interchange

The Arizona Department of Transportation and the Federal Highway Administration, as the lead federal agency, have initiated a study to evaluate alternatives for a proposed, new traffic interchange at Perryville Road and Interstate 10 (Papago Freeway). ADOT and FHWA invite you to attend a public scoping meeting for this proposed project. Scoping is the period during the initial portion of the study when the public is given the opportunity to learn about the proposed project and identify issues to be addressed.

The proposed traffic interchange is another element of the Maricopa Association of Governments' *Regional Transportation Plan* associated with the passage of Proposition 400 in 2004.

The purpose of the meeting is to provide an overview of the study, discuss the environmental and engineering processes and schedule, and provide the opportunity for members of the community to ask questions and express concerns. A brief presentation on the proposed project will be made at the meeting, followed by an open house where representatives from the ADOT study team will be present to answer questions.
